

This is with reference to your application on the subject cited above. In this regard, the undersigned is directed to convey the approval of the Competent Authority for grant of extension of Provisional upgradation of school from pre-school to Sr. Secondary Level (Arts, Commerce & Science / Computer Science) upto 31.03.2034 from the current academic session, under DSEAR, 1973 and RTE Act, 2009 in r/o Saarathi International School, Begumpur Extn. 1. That the school shall submit the latest copy of water test report issued by Delhi Jal Board within 02 months submit the requisite documents to the District Authority.
2. That the school shall appoint the 2nd special educator within 02 months and submit the requisite documents to the District Authority.
3. That the school shall comply with clause 14 of order No. F.DE/15(56)/ACT/2009/778 dated 11/02/2009 in r/o maintenance of DRF, School shall also ensure to follow FN-21 "Accounting by Schools" as issued by the Institute of Chartered Accountants of India (ICAI) for proper accounting treatment.
4. That the school authority shall provide the PF facility to all the staff of the school.
5. That the school shall provide the benefits of Bonus, Medical, LTC, Pension, Gratuity etc. given under Section 10(1) of DSEA&R, 1973 to all the staff within 30 days.
6. That the school shall comply with the order No.DE.15(305)/PSB/2020/Pt.File/5641-5647 dated 20/06/2023 regarding submission of renewed/updated certificates like Fire Noc, Water, Health etc certificates to zone office.
7. That the violation of any instructions/order/rules and regulations of the department, shall lead to the withdraw of recognition of the school.
8. That the school shall comply with the orders dated 07.11.2017/ guidelines of DOE and judicial pronouncement w.r.t. safety of students and shall take all necessary steps to this effect.
9. That in no case the school funds will be diverted/transferred to any other fund/account of the society. The school funds will also not be utilized by the society for any other purpose other than that of the school.
